This master's programme is for practitioners who wish to gain specialist training in psychotherapy for children, teenagers and young people under the age of 25.under the age of 25.

About the Course

The programme sets out to build upon the knowledge and skills that you have developed through your undergraduate education and practical experience as a counsellor and psychotherapist. The programme acknowledges the requirement for all psychotherapists working with children and young people to complete a specialised academic and professional qualification to ensure the highest standards are met. Our programme is intended to align itself with European and international standards and promote continuous development and support for the therapist. The course meets the minimum competency standards for working with Under 18's as developed by the Irish Association for Counselling and Psychotherapy (IACP).



The MSc. Child & Adolescent Psychotherapy programme is a comprehensive professional training course, focused on working therapeutically with young people. The course is validated by Middlesex University* and is designed to supplement trainees' existing qualifications. It is not a stand-alone counselling qualification. Applicants include counsellors and psychotherapists who are accredited or are eligible for accreditation, with the IACP/IAHIP/BACP or equivalent, all of whom seek to deepen or extend their current skills to facilitate therapeutic work with young people up to the age of 25 years.

Course Duration:

24 months; Commencing Autumn 2023

This course will take place at weekends (Saturday & Sunday, approx. 1 weekend per month)

Entry Requirements

Students entering the MSc course must hold a degree (Level 8 NFQ or equivalent; Final grade 2.2 or above) in Counselling & Psychotherapy.

Applicants who do not meet this criterion may be eligible to enter the course on the basis of prior learning and experience in the area. Students applying on the basis of prior learning must provide evidence of their knowledge, skill and ability to pursue this programme of study. This should be in the form of a career portfolio outlining and demonstrating your career path as is relevant to this course (including transcripts of any relevant results, statements of prior learning based on systematic reflection) and be must be submitted with your application.

APPLICATION PROCESS

- Send in Complete Application Form & Deposit
- Copies of Transcripts (Confirming 2.2 on relevant Level 8 Degree or higher) or Copy of Career Portfolio
- 500-word written statement on why you believe you are suitable to the course.
- All suitable candidates will be invited to interview
- Places are limited. Selection is based on application and interview.

Applicants should complete and return the course Application Form accompanied by an initial deposit of €80, which is deductible from course fees if the application is successful. Applicants are entitled to a refund of the initial deposit (less a processing fee of €5) if they decide to cancel within 14 days of receipt of their application, and haven't attended the interview. Please note that the name used on your application needs to be the same name that you have on your passport. Intake interviews will be arranged for suitable applicants. When an applicant has accepted a place, a binding agreement is created and all tuition fees, including deposits, shall be fully non-refundable in all personal circumstances.

Terms & Conditions

Entry Requirements:

It is the responsibility of the applicant to ensure that he/she fulfils the minimum entry requirements for a chosen course, and to ensure that the chosen course is suitable for his/her needs and level of ability. Once an applicant accepts an offer of a place on the course, he/she agrees to abide by the rules and regulations of the College. If the applicant does not reach the acceptable minimum criteria for the course, PCI College has the right to withdraw them from the course.

Language Requirements:

All candidates are required to satisfy the English language requirement. Candidates whose first language is not English and who are presenting qualifications other than the Leaving Certificate may satisfy the requirement through the completion of the IELTS (International English Language Testing System), or equivalent, on the basis that they obtain a minimum band score of 6.5, which denotes a very good skill level of English. It should be noted that these are the minimum requirements in English and PCI College may set higher requirements in each case.

Fees:

<u>Tuition Fees are non-refundable in all personal circumstances.</u> The balance of fees for tuition is payable, in full, before the course commences, or by availing of an agreed PCI College Direct Debit Payment Plan. Tuition Fees do not include costs of Additional Requirements such as Personal Therapy and Supervision. Once a student is enrolled on a programme of study, no part of course fees are refundable or transferable. No refund will be made in any circumstances to students who fail to attend classes or who commence a course and subsequently feel that the course does not suit him/her. Students who are having their fees paid or part-paid by a third party, should be fully aware that responsibility for payment of fees and liaison with these bodies rests solely with the student and not with PCI College.

The College makes every effort to provide the Programme as described, and to avoid altering course dates, tutors, locations etc. However, should any changes be necessary, you will be notified at the earliest opportunity. All courses run subject to demand and the formation of a viable class cohort. A full refund will be given to all applicants in the event that the class does not proceed.

Where a student receives a refund and chooses to keep the refunded fees on their account, this credit shall only be applicable to programmes within that programme category (e.g. counselling & psychotherapy or CPD). Credit will remain on the students account for a period of two years only from the date of refund. PCI College reserves the right to change any of the details given.

Student Requirements:

Students are required to have sufficient IT skills and access to appropriate IT facilities to participate in the course. All students are assigned an individual email address and given access to an online Student Portal. The Portal includes course materials, an online library and College announcements and students are required to upload all written assignments online. Email is the primary communication method of the College and all students are requested to access their individual email account on a regular basis to ensure receipt of all notices.

Students with a disability may require adjustments to facilitate their learning. These adjustments will be fully evaluated by PCI College. Students are requested to make the College aware of any disability, special need or learning support requirement on application.

Garda Vetting:

Students will be requested to participate in Garda Vetting procedures in relation to programme and accreditation requirements. Please note that there is an additional charge of €20 for Garda vetting process which is required prior to course entry and it is not included in the above fees.
